

## **TERMS AND CONDITIONS: WIN A STUDIO TOUR AT DAVINA MICHELLE'S WITH FRESH 'N REBEL**

**THE ACTION:** Sign up for the Fresh 'n Rebel newsletter for a chance to win an exclusive studio tour at Davina Michelle's studio in Dordrecht with a family member or friend of your choice.

Anyone who takes advantage of the action by agreeing to the Terms and Conditions is hereinafter referred to as 'participant(s)'.

Participants can take part in the promotion by signing up to the Fresh 'n Rebel newsletter via the website or social media channels. The participating countries are the Netherlands and Flanders (Belgium).

### **HOW IT WORKS:**

1. Participants have a chance to win the studio tour with Davina Michelle by leaving their personal contact details through the aforementioned channels. The data requested are:
  - a. First and last name
  - b. Age
  - c. Email address
  - d. A rationale as to why that person should win the tour
2. From all applications, three winners will be chosen based on the motivation given in the application. The winners may choose anyone they want to bring along on the studio tour. A total of 6 participants will take part in the tour in Dordrecht. The winner may give away his/her prize.
3. The winners will be notified via a personal email about the prize won. The remaining participants will not receive any notification.
4. The winners will be expected on December 2 at the Fresh 'n Rebel headquarters (own transportation) where they will receive a tour and presentation about the Fresh 'n Rebel brand and the collaboration with Davina Michelle. Here a brunch will be provided by Fresh 'n Rebel. After this the winners will be taken to Davina Michelle's studio in Dordrecht (transportation arranged by Fresh 'n Rebel). The following parties are excluded from participation: (i) employees of Fresh 'n Rebel or Fresh 'n Rebel affiliated companies; (ii) anyone involved in the organization of the promotion; and (iii) direct family members of the persons mentioned under (i) or (ii).
